THE PERSONAL INFORMATION WE MAY COLLECT

- ▶ Your employment, banking and financial information
- ▶ Any other form of personal information that we may reasonably require to offer or provide any of our services or products to you
- ▶ Information we collect through cookies and similar technologies – see more below under the headings 'Cookies' and 'Website Analytics'

WHAT WE DO WITH YOUR PERSONAL INFORMATION

We may use, transfer and disclose your personal information for a number of different purposes. For example, we use it to:

COOKIES

We may use cookies and other techniques such as web beacons when you visit our websites. Cookies are small text files used by us to recognise repeat users, facilitate your ongoing access to and use of our websites, and allow us to track your usage behaviour and compile aggregate data that will allow us to improve the functionality of our websites and content. Web beacons are small, clear picture files used to follow your movements on our websites – for example, storing your preferred settings for the next time you visit.

WEBSITE ANALYTICS

In order to ensure that the content of our websites remains up to date, user-friendly and comprehensive, we employ web analytics tools – the predominant one being Google Analytics, which is a web analysis tool from Google LLC. This service uses cookies that track your

preferences during your visits to our websites and allows us to simplify navigation and make our website more user-friendly. The information that is used during this process (which includes your IP address) is de-identified and makes personal identification impossible.

Pepkor and its subsidiaries may make use of first-party and third-party cookies, as well as web beacons and similar technologies to deliver measurement services and targeted advertising to visitors. Cookies may include, but are not limited to, Google Analytics cookies, Google Ads cookies, and Facebook Event Tracking cookies. No personal information is shared with any third party outside of Pepkor and its subsidiaries when providing these targeted services.
